

SLPPNA Regional Executive Grievance Letter

September 7th, 2020

Dear Council of Elders,

We write to dissociate ourselves from the deliberate and unprofessional actions of the SLPPNA Regional Chairman, Mr. Mohamed Bah, at the September 5th, 2020, General membership meeting in the Region. His undignified actions at the last general membership meeting towards the general membership have created an embarrassment for the rest of the Regional Executive members and brought us into disrepute. We would like to publicly apologize and by way of this letter, invoke a grievance procedure, as Chairman Bah manifested conducts that subverts the aims and objectives of the SLPPNA and SLPP.

According to Article 11(11) of the SLPP National Constitution 2020, Chairman Bah is a NEC and National Party Conference member, we contend that his unpredictable behaviors, disrespect (abruptly ending the general membership meeting) and failure to perform his job duties (Chairing Regional meeting (September 5th, 2020) are in contravention of the SLPPNA 2015 Regional and the SLPP 2020 National Constitution.

We would also like you to know that Chairman Bah has many times apologized to the Regional Executive for sidelining us in decision makings, making presentations on behalf of the Regional Executive without our consents, coupled with his imprudent ways of misguiding us. It is high time we ended this malfeasance in the Region and let Chairman Bah know that we will no longer be subdued to his draconian behavior.

The last straw that broke the camel's back was the way he conducted the general membership meeting on September 5th, 2020:

1. Chairman Bah did not follow the agenda
2. The agreement from the Regional Executive meeting before the general membership was disregarded
3. Chairman Bah did not allow dialogue between the Regional Executive and the General Membership

We are requesting that you investigate this matter with utmost urgency, as we are at a critical crisis in the Region and we want Chairman Bah to know that we will no longer stay silent and a different approach will be taken in future if his behavior does not reflect the office he holds at both Regional and National levels.
